- b Sunday Surcharge per day, per team: R 3 000.00 If Required
- c Admin Charges for OHS & Induction R 2 500.00 If Required
- Quotation valid for 30 days from:
- PAYMENT STRICTLY WITHIN 30 DAYS FROM DATE OF INVOICE.**
- Final total due is subject to calculation after measurement of job on completion.
- An extra site establishment fee will be charged in the event of site not being ready and the team being unable to work.
- Standing time of R1,500-00 per hour will be charged if team has to wait for client for ANY reason.**
- Prices indicated are net – no further discounts will be allowed.
- Late payments will be charged at a rate of 2.5% per month compounded on ALL retention monies.
- Client will be held responsible for payment to Numberline CC for work done, regardless of the fact that the client may not have been paid for the contract.
- A minimum charge of R4,500-00 (excluding VAT) per day will be levied, regardless of the amount of work undertaken.**
- Should the client require that premarking be checked before painting commences, an additional Site Charge will be levied in the event of any alterations from drawings/specifications or instructions.
- All goods, property, signs and markings remain the property of Numberline CC and ownership will only pass to the customer upon receipt of full payment for the said goods, property, signs and markings. Numberline CC reserves the right to remove or obliterate signs or markings in any manner it sees fit should payment not be made on demand.
- NO work will be undertaken unless a firm written, signed order from the client has been received.
- By placing an order based on this quotation, the client accepts and agrees to be bound by all conditions contained herein, and agrees that these conditions will supercede any conditions of order on behalf of the client.**
- A credit application form must be completed by all new clients, if required by Numberline CC, irrespective of the work undertaken. No work will commence until this application has been approved by the credit bureau.
